1. Introduction.

- C. Qualifying Information provided will be used to verify the accuracy of your claim with our systems and relevant Partners..

3. Accessing the LeaseFetcher Discount for Educational Staff, Students and Emergency Services.

- A. To redeem your LeaseFetcher Discount for Educational Staff, Students and Emergency Services, all you have to do is contact LeaseFetcher when you have formally agreed on the delivery of your vehicle.
- B. To verify your claim, you will be required to submit certain information sufficient for us to verify that you are a Qualifying Individual.
